In 1967, David volunteered for the newly created Air Force "Ranger" program and was sent to Fort Campbell, Kentucky to train at the U.S. Army's 101st Airborne School for eventual deployment to South Vietnam. During his time in Vietnam, David served at two air bases, Phan Rang and Pleiku. Upon completion of his tour of duty in 1969, he was transferred to the 1<sup>st</sup> Air Commando Wing at England Air Force Base in Louisiana. David was honorably discharged from active duty with the rank of Sergeant in 1970. While still serving in the Air Force Reserves, David joined a large municipal police department in upstate NY, serving for over 20 years. After retiring, he joined a national police training organization and trained civilian and military police across the country, earning two "Excellence in Training" awards from the U.S. Army Law Enforcement Command at Fort Lewis, Washington. David's medals and citations include the National Defense Service Medal, the Vietnam Service Medal, the Vietnam Cross of Gallantry, the New York State Medal for Merit and the Florida Veterans Service Medal. 

# **BICYCLE AND PEDESTRIAN SAFETY ADVISORY COMMITTEE**

The Bicycle Pedestrian Safety Advisory Committee strives for the enhancement of bicycle and pedestrian paths for the safety of residents and visitors of Bonita Springs. Bicycle Pedestrian Safety Advisory Committee objectives include improving the conditions for bicyclists and pedestrians, promoting bicycling and walking as a means of transportation, and enhancing safety for bicyclists and pedestrians. The Committee also reviews relevant ordinances, organizes public events and works with other bicycle and pedestrian organizations at state and national levels. A main component of this five person committee is to coordinate with other groups so that Bonita Springs will interface and have connectivity with the other bicycle / walking organizations.





# Vaccine Appointments

Appointments are now available at the new FDOH-Lee indoor COVID-19 vaccination site located at the Edison Mall. # CARES ACT Emergency Rental Assistance Program

There is still CARES Act Funding available through the <u>Lee Cares Emergency Rental Assistance</u> <u>Program</u>. Lee County will pay up to six months of past due rent and utilities and three months of prospective payments for qualified households, plus ongoing payment of future rent as permitted. # Sea Turtle Nesting Season Begins on May 1st

Artificial light on the beach can disorient both adult and hatchling sea turtles. The City of Bonita Springs sea turtle protection ordinance requires that sea turtle nesting habitat not be directly or indirectly illuminated by artificial lighting during the nesting season.

The sea turtle ordinance is in effect: May 1 through October 31 - from 9:00pm to 7:00am

### **SEA TURTLE NESTING SEASON Begins MAY 1st**

Each year, between spring and fall, female sea turtles return to the beaches where they were born to build nests, lay their eggs and return to the ocean. After a sixty-day incubation period, the baby turtles are ready to hatch and crawl into the sea. The journey is arduous and according to the Sea Turtle Conservancy, one in 1,000 to 10,000 sea turtles survives to adulthood.

## **Residential Pre-Hurricane Season Maintenance**

All major cutting of vegetation and disposal of yard waste should be completed before the beginning of hurricane season on June 1<sup>st</sup>. Prior to Hurricane Season, proactively survey your property for loose or discarded items that could become projectiles or hazards in a storm. The City of Bonita Springs arranges for removal of debris from routine yard maintenance throughout the year, by way of an interlocal agreement with Lee County. If you are having trees removed or doing any other major cutting, you may consider having your contractor include the price of debris removal as part of their service. You may also consider having the horticultural debris from



major cutting or tree removal transported to a Horticultural Recycling Facility. There is a fee for disposal.

#### What you can do to prepare for Hurricane Season

- 1. Arrange to cut back all trees and weak branches that could contact buildings.
- 2. Clean pallets can be place curbside with garbage.
- 3. Old Fencing (Chain Link) Call Hauler for special pick up. Concrete must be removed from bottom of poles.
- 4. Old Fencing (Wood) -2 yards per week may be stacked neatly and placed curbside for pick up with regular garbage.
- 5. Leaves Must be bagged, containerized, or bundled (each weighing no more than 50 lbs.)

6. Palm Fronds- Up to 50 lbs. can be placed unbundled at curb on your yard waste pick up day. Large quantities should be bagged/containerized/bundled, with each bundle no heavier than 50 lbs. in weight.

7. Tree Branches, Brush- Branches should be cut to no longer than 6 feet in length and bagged/bundled or containerized in bundles no more than 50 lbs. in weight.

8. Burning of horticultural debris or yard waste is not permissible within City limits.

9. Clean your yard of any items that could pose a danger to you or your neighbors in hurricane force winds such as old lumber, broken lawn furniture, etc. and place curbside on your bulk waste collection day.

## Once a tropical storm or hurricane warning has been declared

- 1. Do not cut down trees or do major yard work.
- 2. Do not begin construction projects that produce debris.
- 3. Once a watch or warning has been issued, do not trim vegetation of any kind.

4. Mass cutting places a tremendous burden on the collection and disposal processes and there is not enough equipment or manpower to handle the additional material before the storm makes landfall. You could put not only yourself at risk but your neighbors as well.

5. Contact hauler or facility before taking materials to a transfer stations or landfill during a watch or warning period. Services may be suspended during this time and facilities closed early to prepare for the storm.

## The time to develop and practice your emergency plan is prior to hurricane season.



Prepare your Emergency Supply Kit before the start of hurricane season. Add a few pieces to your supply kit each week so that it doesn't break your budget. Remember to check your kit often and rotate the non-perishable food items in your kit.

# **ORDINANCE EXPLAINED**



### Landscape irrigation shall be prohibited daily between the hours of 9:00 a.m. and 5:00 p.m.

Watering Options: Year-Round Landscape Irrigation - Users may irrigate on two days or may exercise the option to irrigate a third day.

#### When can I water the lawn in Bonita Springs?

Odd-numbered street addresses may water lawns and landscapes on Mondays, Wednesdays and/or Saturdays, only midnight until 9 a.m. OR after 5 p.m. until midnight.

**Even-numbered** street addresses, **no street address** or those that **irrigate both even and oddaddresses** within the same zones, which may include multi-family units and homeowners associations, may water lawns and landscapes on **Tuesdays**, **Thursdays and/or Sundays**, **only midnight until 9 a.m. OR after 5 p.m. until midnight**.

#### When can I water my newly planted landscaping and sod, less than five acres in size?

**1 to 30 days:** from midnight until 9 a.m. OR after 5 p.m. to midnight on Mondays, Tuesdays, Wednesdays, Thursdays, Saturdays and Sundays.

#### Irrigation is not permitted on Fridays.

**31 to 90 days:** from midnight until 9 a.m. OR after 5 p.m. to midnight on Mondays, Wednesdays, Thursdays and Saturdays.

These rules permit new landscape watering only. Homeowners should keep documentation on any new landscaping, such as a dated receipt of purchase, in case they are required to provide proof of the installation date.

#### Irrigation is not permitted on Fridays.

**Can I hand-water my lawn?** Yes. You can hand water stressed plants for 10 minutes per day using a single hose with an attached automatic shut off nozzle.

**What other low-volume watering methods are allowed?** Persons using a low volume irrigation system will be allowed to water seven (7) days a week except during the hours between 9:00 a.m. and 5:00 p.m. Drip, bubble and micro-jet systems that apply water directly to rootplant zones may be used any time. However, a voluntary reduction in use is encouraged and any low-volume system should not produce water runoff. Watering cans are also low-volume and can be used anytime.

**When can I wash my car or boat?** Anytime. Vehicle washing is not restricted. When washing a car, best water conservation practices are to park it over a non-paved or porous surface to limit water runoff, and always attach an automatic shut-off nozzle to your hose. Best water conservation practices are to limit boat rinsing to 15 minutes after it has been in saltwater.

**When can I use a pressure washer?** Anytime. Pressure washing is not restricted. Best water conservation practices are to use low-volume equipment that produces water pressure of 1,000 pounds per square inch to 4,000 pounds per square inch.Channel runoff water onto the grass or another non-paved surface. At restaurants, just ask. All restaurants within the City of Bonita Springs are prohibited from serving water to any customer from any public or private well, water supply, or distribution system except when specifically requested by the customer.

**Is there some way I can get permission to change my watering day or times?** Yes. You may apply for a variance from water restrictions by contacting South Florida Water Management District. However, you must demonstrate a hardship in complying with the restrictions and certify that you will implement an alternative method for achieving the target cutbacks. The application and instruction forms are online. Your application will be reviewed by South Florida Water Management District staff, and approval or denial is based on criteria listed in the <u>Water Shortage Plan Rule</u>. **What happens if I don't follow these restrictions?** Any irrigation performed from 9:00 a.m. to 5:00 p.m. will be subject to fines. Irrigation during these hours wilts sod and plants and wastes water through evaporation. Water restrictions are mandatory and will be enforced by local government through law enforcement or zoning and code enforcement agencies.



# Did You Know.....

The City of Bonita Springs held the Hazardous Waste Collection Event for its residents on April 7th. Residents were able to safely and responsibly dispose of household chemical waste like leftover paints, cleaners, herbicides, pesticides, automotive fluids and pool chemicals. The HCW Collection is part of the City of Bonita Springs interlocal agreement with the County to provide residents convenient and responsible disposal of chemicals that might otherwise be harmful to people and the environment.



**FPL Underground Conversion Project** — The City Council has approved moving forward with Florida Power & Light Company's Underground Facilities Conversion Agreement for West Terry Street from Pine Avenue to Edenbridge Court. This project will convert existing electric poles to underground facilities on the north side of West Terry Street, along the recently completed multi-use pathway. This project will support fewer number of power interruptions, no poles or overhead wires in the conversion area and better reliability in normal and adverse weather conditions, especially during wind and lightning events. This project is projected to be completed in 2022.

**Incoming Funds for Multi-Use Paths** - this past January City Council agreed to move forward with a sub-recipient agreement with Lee County that would provide funding for Multi-use Paths throughout the city. The Department of Housing and Urban Development recognizes Lee County as an Urban County in the Community Development Block Grant program. As such, the County is designated as the Lead Agency to implement yearly entitlement funds. Cities within the County (Bonita Springs, Sanibel, and Fort Myers Beach) have agreed to partner with Lee County to manage their yearly entitlement allocation since early 2000. Since 2004, Bonita Springs has partnered with Lee County through an Urban County Cooperation Agreement.

City staff received the sub-recipient agreement from Lee County Human and Veterans Services on January 5, 2021 which contains a one-year agreement that covers the City's entitlement funds for FY 2020 -2021. The funds received from this agreement, which total \$371,384, will be designated to various multi-use paths projects throughout the City.

# Did You Know.....continued

The Public Works Department is currently working on the following projects:

Maddox Lane Sidewalk & Drainage Project – City Council has approved a resolution awarding Infinite Construction LCC with the Maddox Lane Sidewalk and Drainage Project. Infinite Construction LLC will construct a new sidewalk along the south side of Maddox lane between Cockleshell Drive and Paradise Road. The new sidewalk will include drainage structures and swale and ditch regrading for improved storm-water flow, along with other improvements to the area affected by the construction. The new sidewalk is projected to be complete by the end of the 2021.

West Terry Street Pathway Extension – The West Terry Street Pathway extension project includes the construction of an eight foot wide concrete pathway, along the north side from Pine Avenue (easterly) to the west side of the outfall ditch/railroad. A pedestrian seating area behind the current bus stop at the north-west corner of Palm Street will be added. This \$4.7 million project strives to improve Bicycle Pedestrian safety and connectivity, in line with the transportation strategic priority identified by City Council.









# Gulf Coast Garden Club & The City of Bonita Springs BLUE STAR MEMORIAL HIGHWAY DEDICATION



In 1945, the National Council of State Garden Clubs. Inc. approved the Blue Star Memorial Highway Marker program. Old Route 41 is now a Blue Star Memorial Highway.

The First Blue Star Marker in Bonita Springs was dedicated on March 29th. The Gulf Coast Garden Club had been working with the city and raising funds for the sign dedicated to our Armed Forces.





The purpose of the Blue Star Memorial Highway project is to erect highway markers at roadside rest stops, vista points, historical sites and other appropriate areas to pay tribute to all who have served, those who are presently serving, and those who will serve in the nation's armed forces.

# **Proposed Additions to Bonita Springs Pool Facility**

Council has approved moving forward with discussions regarding the addition of a children's water playground and two family restrooms at the city's pool facility. In 2016, the City hired Stantec Consulting Services to design a Children's Activity Pool addition to the City's community pool that included expanded locker rooms and a family restroom facility. This project was fully designed with LDO approval and shovel ready plans. At that time, the construction costs were estimated to be \$750,000, and the project was slated to be funded with Park Impact Fees. The project was then placed on hold due to its cost and other city priorities at the time, with the intent for staff to revisit this project in the future.

In recent discussions, the City Attorney has advised that a family restroom should be constructed at the City's Community Pool for liability purposes. The estimated cost of a family restroom facility is approximately \$200,000. The pool facility is also currently in need of a roof replacement with a cost of \$45,000. Council has directed staff to reach out to Stantec for updated pricing for the proposed improvements and to move forward with discussions for the project in its entirety as a Capital Improvement Project for the upcoming budget.

The City of Bonita Springs Recreation Center is located at 26740 Pine Avenue off West Terry Street. Our Facilities include a full-sized gymnasium and a cardiovascular/fitness room with locker rooms available for use.
