Dear Members of the 2022 Redistricting Committee

I am excited to see redistricting on the City Council Agenda. It's obvious that Bonita Springs has experienced a tremendous amount of growth in population since the previous census. The diversity of growth and increase in commerce in our city is so exciting.

When I look at a map of the current City Council Districts and apply the population growth, I believe our city has outgrown six districts. The current boundaries of District Four have the council person representing a very diverse neighborhood/city experience. By dividing the district, the representation on the city council would more acutely reflect the experience of all citizens living in Bonita Springs. I would suggest dividing District Four into two districts. One would be a new district. In reviewing the current district map several things become readily apparent. I believe the population growth in the current district has exploded since the last census. In looking at the map of current population vs. square mile, it's obvious that this area deserves more representation in local government.

When viewing the current district map, you can't help but notice the difference in the number of large, gated HOA's in one area of the district, while other areas have fewer communities involved with an HOA.

While citizens who are not involved with an HOA certainly have considerably less expense, they also have a disadvantage when things in the neighborhood go in the wrong direction. Those citizens deserve someone in local government to represent them who understands the quality and quantity of issues these individuals may experience. Those of us living with no or a small HOA need a council person who understands and can relate to the challenges that living with few restrictions can bring. Of course, this affects our quality of life since home ownership is our strongest and biggest asset and we need a voice on the City Council.

To: Bonita Springs Mayor and City Council,

I am and have been a resident of Bonita Bay in Bonita Springs. As a member of the community, I am writing to voice strong objection to redistricting the City in a manner as to severely repress and dilute my representation in the City by improperly gerrymandering two large groups, Bonita Bay and Pelican Landing, into a single council district. Two of your consultant's proposals do just that and it means that a total of HALF the City's taxpayers will have *only ONE of 7 Council seats*. That creates oppression and taxation without adequate representation.

A consultant hired by you has developed three redistricting proposals. One of the proposals is largely the same as our current districting which includes communities along Spring Creek to its headwaters north of Shangri-La Road. This is reasonable and supportable.

However, the other two proposals would combine Bonita Bay into a single district with Pelican Landing. Together with Cedar Creek and Highland Woods which are already in our District, Bonita Bay and these communities would **provide more than 50% of the City's tax revenues**. But we would have **just 1 or 14% of the 7 Council seats**. In other words, our financial contribution to the City would be three and a half times as great as our electoral influence. That is likely unconstitutional. But more than that, it is unfair and would demonstrate an abuse by our elected leaders.

Please do the right thing and reject your consultants 2 proposals that create biased and unfair representation!

We are residents of Bonita Springs, and live in Bonita Bay. We have been Florida residents here for 24 years. We were here as Bonita Springs fought for its independence and the creation of the City of Bonita Springs from unincorporated Lee County because our tax dollars were being funneled to other areas of Lee County without any appropriate input from the citizens of Bonita Springs. Even though at that time Bonita Springs was the fastest growing part of Lee County's tax base. The creation of the City of Bonita Springs allowed our residents to have appropriate representation for our share of the tax base we represented.

We understand a similar type of issue may arise if some proposed new District maps are approved for Bonita Springs. Apparently several possible redistricting maps combine Pelican Landing and Bonita Bay into one District, as opposed to the 2 separate districts they now have. Bonita Bay and Pelican Landing generate over 50% of the tax revenues for the City of Bonita Springs. But if they are placed under one District they will have only 1 vote out of 7 on the Council, which means over 50% of the tax base only receives 14% representation. This does not seem appropriate nor fair. In fact sounds like the type of mis representation of a tax base which led to the creation of the City of Bonita Springs.

We urge you not to approve a re districting which would combine Pelican Landing and Bonita Bay into one District. It would create an inappropriate misbalance of tax base and its citizens and their representation on the Council for matters directly impacting those citizens.

I am opposed to diluting the electoral representation of the Bonita Bay community in Bonita Springs. I'm not requesting increased representation, just fair and equitable representation in accordance with our population.

It is an injustice to reduce our representation to half our "fair-share" based on our community's population by combining us with another community. Our current representation is population appropriate:

- 6,500 population of Bonita Bay divided by 53,644 population of Bonita Springs = 12.1%.
