II. Pledge of Allegiance

III. Public Comment

Mr. Purdon introduced Mr. Jean Beauvoir and asked him to tell the Committee a little about himself.

Mr. Beauvoir introduced himself explaining that he has lived in Bonita Springs for about 10 to 12 years on and off. Mr. Beauvoir is a recording artist who has managed a couple of entertainment companies. Mr. Beauvoir would like to be more active in the community.
